Sequential

Each demolition is carried out in a sequence engineered for optimal safety and efficiency.

Mechanical

Our state-of-the-art fleet lets us deploy mechanical demolition techniques that others can't, such as stateof-the-art Long-Reach excavators for tall structures.

Manual

From hazmat removal to remediation work, manual demolition is performed by quality skilled labour, trades and operators.

Robotic

Induced collapse

A method of controlled demolition in which structural stability of the whole or part of the structure is deliberately altered so that collapse ensues.

Implosion

Collapsing a structure so that it falls straight down on its original footprint size. This requires excellent planning and preparation.

Our stringent sustainability targets help you achieve yours. We've implemented ISO 14001 (Environmental Management Systems) to enhance our end-to-end environmental performance.

Construction and demolition waste is one of the biggest contributors to waste in Australia. As a major operator, we believe it's our shared responsibility to decrease the amount of waste generated by the construction industry. In every Perfect project we:

- Supply multiple waste and rubbish removal services across all tiers of clients. By employing on-site segregation we can ensure all materials are sorted into categories allowing us to earmark over 90% of all material for reuse or recycling.
- Employ a trailing liability mechanism so that each batch of material is documented on-site specifying both the type of material and where it came from.
- Utilise licensed and reputable transporters for carting the material from the site to a licenced recycling facility. **Digital tracking** systems maintain a record of material movement.
- Exclusively use licenced disposal facilities for recycling. These facilities generate dockets to maintain a disposal register for all material recycled.
- Maintain a chain of custody for material, documenting each stage from collection, transportation, processing and final disposal.

What does an Unrestricted Demolition Licence mean?

This licence is required to demolish (or partially demolish), any building, structure or installation that:

- is over 15 metres in height
- is a chemical installation
- involves a tower crane on site
- involves a mobile crane with a rated capacity of more than 100 tonnes
- has structural components that are pre-tensioned or post-tensioned
- involves floor propping
- involves explosives

Friable and Non-Friable Asbestos Licenses

A Class A license allows us to:

- Remove friable asbestos or asbestos-containing material (ACM)
- Remove friable asbestos fire doors and safes

A Class B License allows us to:

• Remove more than 10m2 of non-friable asbestos or asbestos-containing material (ACM). This includes asbestos-contaminated dust.

What is Asbestos Removal Liability Insurance?


Asbestos Removal Liability Insurance protects the insured against bodily injury and property damage claims arising out of the activity of removal of asbestos.

PROJECT LIFECYCLE

1. Tender
